1) CopperDog 150 / CopperDog 80 / CopperDog 25

The **CopperDog 150 (CD150)** is a 122-mile (approx.), 10-dog/10-dog pool, 3-stage professional race open to dog mushers that meet the entry requirements set forth by the CopperDog 150 Board of Directors. The **CopperDog 80 (CD80)** is a 72 mile (approx) 8 dog/8 dog pool 2-stage race open to dog mushers that meet the entry requirements set forth by the CopperDog Board. The **CopperDog 25 (CD25)** is a 14-mile (approx.), 6-dog, 1-stage race open to dog mushers that meet the entry requirements set forth by the CopperDog 150 Board of Directors. The intent of these rules and regulations are to ensure safe, friendly, and fair competition. The CopperDog Race Officials are responsible for interpreting the rules to ensure that intent.

2) Overview – Race Officials

BOARD OF DIRECTORS – The governing body of the CopperDog 150 races responsible for all aspects of planning and execution of the event. The Board of Directors has absolute authority over all aspects of the CopperDog 150 event.

RACE DIRECTOR – Is responsible for planning, promoting, managing, and timely execution of all technical aspects of the race; responsible for overall event operation and safety.

RACE MARSHAL – Is responsible for the enforcement of CD150 race rules in a manner that provides all participants with fair and unbiased competition; oversees the Race Judge(s); has final authority, except where overruled by the Board of Directors, on all aspects of the race from the mandatory drivers meeting through the awards ceremony.

RACE JUDGE – Works under the direction of the Race Marshal and is responsible for the enforcement of CD150 race rules and provides all participants with fair and unbiased competition.

CHIEF VETERINARIAN(S) – Oversees the health and safety of all dogs entered in the race; in charge of all dog health and safety issues from the first mandatory vet check until the awards banquet (and, in the case of drug testing or necropsy issues, until those issues are resolved); has final authority on all matters of dog care and treatment; oversees the Race Veterinarians.

RACE VETERINARIANS – Work under the direction of the Chief Veterinarian(s) on all aspects of dog care, safety, and health. Race veterinarians may recommend withdrawing a dog or team for health reasons at any time during the race.

TRAIL BOSS – Will prepare, maintain, and sign the race trail; advises Race Director, Race Marshall, and Chief Veterinarian on changing trail conditions; have input into all matters relating to the trail.

3) Entry Fees (U.S. Funds)

The entry fee for the **CopperDog 150** is (entry fee include a commemorative CopperDog item):

\$375 for entries received by **February 21, 2022**.

No entry accepted after **11:59PM, February 21, 2022**.

The entry fee for the **CopperDog 80** is (entry fee includes a commemorative CopperDog item):

\$250 for entries received by February 21, 2022.

No entry accepted after 11:59PM, February 21, 2022.

The entry fee for the **CopperDog 25** is (entry fee include a commemorative CopperDog Item):

\$125 for entries received by **February 21, 2022**.

No entry accepted after **11:59PM, February 21, 2022**.

4) Withdraw and Refunds:

Refunds are typically issued within two weeks of notification to withdraw.

- Withdraw before **January 31, 2022** and received a **100%** refund of the registration fee.
- Withdraw between **Feb 1, 2021 and Feb 21, 2022** and receive a **50%** refund of the registration fee.
- **No refunds** will be issued to entrants who withdraw after **February 21, 2022**.

5) Race Changes

Mushers entered in either the **CopperDog 150**, **CopperDog 80** or the **CopperDog 25** may request a one-time option to switch races, withdrawing from one and posting a new entry for the other race. This one-time switch may be done until the last date for entry, however a place on the race roster is not guaranteed. A musher switching from one race to the other is considered a new entry and will be placed at the end of the race roster for the desired race, or at the end of the waiting list (if applicable).

The entry fee for the race being entered applies as of the date of the switch. One-Hundred percent (100%) of the original paid entry fee may be applied to the new race entry fee. If the musher is unable to run the race because of being on a waiting list (i.e. the roster was full when the musher opted to switch races), the Musher receives a refund using the date of change as the basis for withdrawal in accordance with the above mentioned refund policy.

6) Race Entry

The CD150 Board reserves the right to reject any entry for just cause.

Maximum of **2 (two)** teams allowed to register in any race format with a maximum of **3 (three)** teams across all race formats from each kennel may register.

The **CopperDog 150** will be limited to **25 (twenty-Five)** mushers (subject to minor changes by Board approval).

The **CopperDog 80** will be limited to **25 (Twenty-Five)** mushers (subject to minor changes by Board approval)

The **CopperDog 25** will be limited to **20 (twenty)** mushers (subject to minor changes by Board approval).

7) Bib Draw

The CD150 Board is responsible for the bib draw and will conduct the bib draw prior to the mushers meeting. Bib numbers will be drawn in rounds.

Round 1 will be for mushers who registered for the race before or on **November 15, 2021** from a pool of bib numbers equal in size to the number of mushers who qualify for the first round bib draw. Lowest numbered bib numbers will be pooled.

Round 2 will be for mushers who registered for the race before or on **December 15, 2021** from a pool of bib numbers equal in size to the number of mushers who qualify for the second round bib draw. Lowest numbered bib numbers of the bib numbers that have not been issued will be pooled.

Round 3 will be for mushers who registered for the race on or before **January 15, 2022** from a pool of bib numbers equal in size to the number of mushers who qualify for the third round bib draw. Lowest numbered bib numbers of the bib numbers that have not been issued will be pooled.

Round 4 will be for mushers who registered for the race on or before **February 15, 2022** from a pool of bib numbers equal in size to the number of mushers who qualify for the third round bib draw. Lowest numbered bib numbers of the bib numbers that have not been issued will be pooled.

CD150, CD80 & CD25 Bib numbers will be given to mushers at Registration on Friday and Saturday. CD150 Board will resolve any issues involving the bib draw.

8) Mushers

All mushers entering the **CD150, CD80 & CD25** must adhere to the **COVID-19 Pandemic Safety Plan** (Attachment 3) and sign that they have read and understand.

All mushers entering the **CD150** must have competed in an event with a minimum of **40 miles** of continuous running within the past three seasons. A waiver may be requested.

Mushers under the age of 18 (eighteen) may participate with approval of the CD150 Race Director or the Race Marshal, and a waiver of liability signed by a parent or legal guardian.

Only one musher per team is permitted and no substitutions will be allowed after the team starts the race.

Substitution of mushers will be allowed up to the beginning of the Friday's mandatory mushers' meeting with the approval of the CD150 Race Director, or at any time before the team starts the race with approval of the Race Marshal.

All mushers in **CD150, CD80 & CD25** will read and sign the electronic musher meeting prior to registration and vet checks on **Friday March 4, 2022**. CD150 mushers will also meet at **3:15 PM (EST) Saturday March 4th, 2022 at a location TBD in Copper Harbor**, unless deemed unnecessary. In addition, we will hold a musher meeting before each leg of the race for CD150 and CD80, **7:30 AM (EST) Saturday March 5th, 2022** and **7:00 AM (EST) Sunday March 6th, 2022** unless deemed unnecessary by Race Officials. The other mandatory meeting for all mushers, **Sunday March 6th 2022**, following the awards.

Only the mushers may participate in discussions held at the meeting following the awards. This meeting is intended to allow open and respectful discussion within the musher group without interference or immediate feedback from the race organization.

Missing the second roll call at the meeting, taken **10 (Ten) minutes** after the first roll call has been completed, may, at the discretion of the Race Marshal, mean disqualification. A penalty of **\$100** may be assessed for missing the second roll call.

Musher representatives will be selected at the musher meetings to serve on an appeals jury if needed. There will be one representative and one alternate selected from among the entrants for each race.

Unsportsmanlike Conduct

Participants, handlers and team members shall refrain from unsportsmanlike conduct, including improper use of language or conduct directed towards Race Officials, Volunteers, Fans, and other mushers. Violations of this nature may result in a time penalty, monetary fine, and/or disqualification from the race.

9) Dogs

Each **CD150 team** must start the race out of Calumet with a minimum of **8 (eight)** dogs and finish with a minimum of **7 (seven)** dogs hooked inline into Eagle Harbor. Each team must leave the Eagle Harbor checkpoint with a minimum of **7 (seven)** dogs in line and finish with no less than **6 (six)** dogs in line into Copper Harbor. Each team must leave the Copper Harbor checkpoint with a minimum of **7 (seven)** dogs hooked inline and finish with no less than **6 (six)** dogs hooked inline into Eagle Harbor. The **CopperDog150** is a 10-dog race with a 10-dog pool. Musher's may choose to start with 8 dogs on Stage 1 and move up to 10 dogs for stage 2 and 3. Musher's must adhere to the minimum number of dogs' inline for each start and finish.

All dogs not in the 10 dog pool must be marked out prior to race start. Dogs dropped at any checkpoint will be marked out. It is the musher's responsibility to make sure that any dogs not continuing the race are marked out by event veterinarians.

Each **CD80 team** must start the race out of Eagle Harbor with a minimum of **7 (seven)** dogs and a maximum of **8 (eight)** in line and finish with a minimum of **6 (six)** dogs hooked inline into Copper Harbor. Each team must leave the Copper Harbor checkpoint with a minimum of **6 (six)** dogs hooked in line and finish with no less than **5 (five)** hooked inline into Eagle Harbor. The CopperDog 80 is a 8-dog race with a 8-dog pool.

All dogs not in the 8 dog pool must be marked out prior to race start. Dogs dropped at any checkpoint will be marked out. It is the musher's responsibility to make sure that any dogs not continuing the race are marked out by event veterinarians.

Each **CD25 team** must start the race out of Copper Harbor with a minimum of **5(Five)** dogs in line and finish with a minimum of **4(Four)** dogs hooked in line into Copper Harbor.

10) Mandatory Veterinary Exam

All dogs participating in the **CD150, CD80 and CD25** must undergo a physical examination by one of the veterinarians. Only dogs found to be in good health and fit to compete will be permitted to run in the race.

All dogs entered in the race must be current with vaccinations for parvovirus, distemper and rabies. Proof of valid rabies vaccination from the musher's state of residence signed and dated at least two weeks prior to the race by a licensed veterinarian is required. Dogs coming from Alaska having valid certificates by Lay Vaccinators will be accepted. Proof of purchase for valid vaccines for other vaccinations must be submitted for inspection. Proof of distemper and parvovirus must come from a Veterinarian OR administered by owner or driver; records must include type of vaccine, proof of purchase (i.e., receipt) and the date of vaccination in writing for each dog. Race veterinarians will not vaccinate dogs during the Vet Check.

Teams in the **CD150**, 10-dog race/10-dog pool may have a maximum of 10 dogs checked by veterinarians.

All 10 dogs checked by the veterinarian will be marked or tagged for identification along the race route. After the start of the race no marked out dogs will be permitted to race. Any dog riding in the musher's vehicle and not participating in the teams' ten dog pool must be "marked out" by a race veterinarian prior to leaving the start area.

Teams in the **CD80**, 8-dog race/8-dog pool may have a maximum of 8 dogs checked by veterinarians.

All 8 dogs checked by the veterinarian will be marked or tagged for identification along the race route. After the start of the race no marked out dogs will be permitted to race. Any dog riding in the musher's vehicle and not participating in the teams' ten dog pool must be "marked out" by a race veterinarian prior to leaving the start area.

Teams in the **CD25**, 6-dog race may have a maximum of 6 dogs checked by veterinarians.

All 6 dogs checked by the veterinarian will be marked or tagged for identification along the race route. After the start of the race no marked out dogs will be permitted to race. Any dog riding in the musher's vehicle and not participating in the teams' ten dog pool must be "marked out" by a race veterinarian prior to leaving the start area.

Teams must sign up for assigned Vet Check slots prior to the start of race weekend. Vet Checks for **CD150** will be **Friday March 4th** prior to the race, Vet Checks for the **CD80** will be on **Saturday morning March 5th (unless requested for Friday March 4th (shared rigs, etc))** and vet checks for **CD25** will be **Saturday, March 5th** prior to the race.

11) Veterinary Guidelines

No injectable, oral, or topical drug which may suppress the signs of illness or injury may be used on a dog. Mushers may not inject any substance into their dogs. No other drugs or artificial means may be used to drive a dog or cause a dog to perform or attempt to perform beyond its natural ability.

Mushers may administer the following compounds to their dogs orally without veterinary consent: Vitamins, minerals, electrolytes, enzymes, probiotics, and any dietary supplements marked as such, provided that these compounds are maintained in their original containers with labels indicating their contents.

The administration of any substance to a dog orally, by syringe, by needle, or similar device (basting) by a musher is prohibited.

The use of topical corticosteroids is limited to use on the paw/pad. The only corticosteroid containing topical products permitted for this race will be those dispensed by the race veterinarians.

The use of megestrol acetate (ovaban) and mibolerone (cheque drops) as an estrus suppressant is permitted in intact females that have not had an ovariohysterectomy.

Personal prescriptions written for and carried by the mushers may not be used on the dogs.

Race veterinarians may utilize any of the below listed drugs or other prohibited drugs necessary to maintain a dog's health, however, such dogs will be withdrawn from the race. The use of local or general anesthetics will not be allowed in any form unless the dog is withdrawn from the race. The use of any other drug not included on this list and deemed necessary for the health of the dog by the musher's veterinarian will be reviewed on a case by case basis by the Chief Veterinarian(s).

Prohibited drugs:

Anabolic steroids

Analgesics (pain relievers) both prescriptive and non prescriptive.

Anti-inflammatory drugs, including but not limited to:

- o Corticosteroids (the exception is the use on feet)
- o Non steroidal Anti-inflammatories (NSAIDS)
- o Salicylates
- o DMSO
- o Antiprostaglandins

Anesthetics

Central nervous system stimulants

Antihistamines

Bronchodilators

Cough suppressants

Diuretics

Injectable anticholinergics

Muscle relaxants

Tranquilizers and Opiates

The CD150 Board of Directors reserves the right to collect blood and/or urine samples, at the discretion of the Chief Veterinarian(s), at random any time commencing from the official Vet Check to the beginning of the awards ceremony of the respective race.

The musher or handler designated by the musher must assist the veterinarian in collecting samples whenever requested.

If blood or urine testing of a dog reveals any of the prohibited drugs in the dog, this rule has been violated regardless of when such drugs were administered to the dog.

If in violation of this rule, musher will be disqualified and a penalty will be determined by the Race Officials.

Monitoring Criteria

Using ISDVMA guidelines, the following vital signs are indicators of health problems, which would require the withdrawal of a dog from the race:

7% - 8% dehydration

Heart rate 120 beats per minute or higher after 30 – 60 minutes of rest with or without a prolonged capillary refill time.

Body temperature greater than 103 F after one hour of rest.

Lung sounds with evidence of edema, rales, or cough.

Hypothermia: a body temperature less than 99 F.

Non-responsive diarrhea with blood associated with weight loss or dehydration.

Severe lameness, especially of the shoulder.

Seizures

Brown or red urine

Chiropractic manipulation, Acupuncture, and Therapeutic Laser are recognized veterinary treatment modalities and, as such, their use during the CopperDog 150 is under the jurisdiction of the Chief Race Veterinarian(s). Because it is impractical for the race veterinary team to ensure these treatment modalities would be uniformly available to all competitors, their use will be prohibited from the pre-race veterinary exam to the end of the race. If, after consulting with the Chief Race Veterinarian(s), a competitor feels their dog needs to be treated with one of these modalities, a decision may be made to allow the use of that dog, but that dog must be dropped from the race.

The death of any dog may result in the disqualification of the musher and/or prohibition from participating in future CopperDog 150 events. Any dog that expires during the race for any reason must be taken to the next or previous checkpoint. The musher shall notify the nearest Race Official at first opportunity. If a Race Official is not available, the nearest Race Veterinarian shall be notified. At the discretion of the Chief Veterinarian(s) a necropsy may be required. If required this shall be performed by a licensed Veterinary Pathologist or Veterinarian.

12) Equipment

All harnesses must be padded around the neck and chest areas and have **reflective tape or material**.

All ganglines must be arranged for single or double file disposition.

A sled must be equipped with a working brake bolted to the sled, a brush bow and snow hook.

A sled/dog bag capable of safely restraining a struggling or injured dog must be on the sled.

Any sticks or poleing devices (e.g. ski poles) must have at least 8" of reflective tape or material.

13) Mandatory Gear

For CD150, CD80 & CD25 (items marked '*')

- * Race Bibs (must be worn by musher with number and sponsor visible at all times while on the trail)
- * Musher's veterinary log book
- * Snub lines at race starts where available
- * Snub line for starts at checkpoints
- * If using a cable gangline, cable cutters capable of cutting gangline (not a Leatherman or similar utility knife)

Dog harnesses with reflective material or tape

Two (2) complete working headlamps

- * Sleeping bag with an arctic rating of 0°F (zero degrees) or colder

- * One set (4) of booties per dog

- * A musher determined portion of food per dog (when leaving start and each checkpoint)

One day's ration of food for the musher leaving each start and each checkpoint

- * Knife (recommend in an easily accessible location)

- * First aid kit (for musher and dogs) including Ace bandages and pressure dressings for severe bleeding

- * Compass

- * Waterproof matches or a lighter

A musher's headlamp must remain on at all times after dusk.

A red blinking light on lead dog is mandatory during hours of darkness.

- * Promotional materials, as determined by the executive director and race director including sled banners.

Snowshoes (optional)

14) Acceptable/Prohibited Equipment

Acceptable Equipment:

MP3 Player

CD Player

Standard AM/FM Radio

Cameras

Video Recorders

GPS equipment

Cell Phones (without phone/two-way radio capabilities)

Prohibited Equipment:

No two-way radios

Any musher found with prohibited equipment during the race will be penalized.

15) Officiating

Race Officials

Race Marshal has the following responsibilities:

In charge of all aspects of the race from the Friday's mandatory mushers' meeting through the Awards ceremony

Final authority and interpretation of all rules

Final determination for alteration of race, start location, and race route changes

Final determinations of winners and placing

The **Race Judge(s)** shall act in concert with the Race Marshal and will hold authority within their specific locations as assigned by the Race Marshal.

The **Chief Veterinarian(s)** shall have final authority over the disposition of any dogs for medical reasons.

The **Race Marshal** and **Race Judges** shall consult with the **Chief Veterinarian(s)** regarding any determinations of disqualification of any dogs or teams in regards to dog welfare.

The **Race Marshal** and **Race Judges** shall consult with the **Trail Boss** regarding any determinations of issues involving the race trail.

The **Race Veterinarians** are Consulting Specialists to the race and have the right to examine any dog at any checkpoint during the race. In addition to the pre-race vet check, they will be available throughout the race for consultations, first aid, and major medical situations. Their recommendations to disallow entry or remove a dog or team from the race may occur at any time during the race and will go directly to the Chief Veterinarian(s), who, in conjunction with the Race Marshal, will make the final decision. In the absence of the Chief Veterinarian(s), the concurrence of two or more veterinarians in consultation with a Judge may result in disallowing entry, removal, or holding of a dog or team from the race.

The **Executive Director, Race Director, Asst. Race Director, Chief Timer, Race Judge(s), Race Veterinarians, Trail Boss** and other appointed officials each have immediate authority in their specific area of responsibility and will act as consultants to the **Race Marshal, who has ultimate responsibility for final decision making.**

16) Musher's Responsibilities

Mushers are responsible for the conduct of their dogs, handlers and representatives before, during and after the race.

The musher is required to report all violations of race rules and regulations to the Race Marshal, a Race Judge, or if no Judge is available they may report to a Race Official (who in turn will notify a Race Judge or the Race Marshal). Forms for reporting violations will be available at every checkpoint.

Any musher who knowingly fails to comply with race rules and regulations as stated herein will face disqualification, monetary penalty, or time penalty depending on the nature of the violation as determined by the Race Marshal.

A musher withdrawing from the race either between checkpoints or at any checkpoint for any reason must immediately notify a Race Official. Failure to do so may result in a one-year disqualification.

It is the musher's responsibility to make sure that any dogs not starting or continuing the race are marked out by event veterinarians.

Mushers must return the follow race materials at the conclusion of the race:

**Sponsor Sled-Banner with bib number written on it and musher's signature
(Sled banners are returned to sponsors as keepsakes)**

Mushers may retain (keep and take home) the following race materials at the conclusion of the race: Race Bib

Penalties, disqualification, and protest procedure

Penalties and Disqualification

Rule infractions may result in an issuance of warnings, monetary penalties, time penalties, censure, or disqualification. Warnings may be issued by any Race Judge. Monetary penalties and time penalties require the agreement of at least one Race Judge and the Race Marshal. Disqualifications require a unanimous decision of Race Judges as well as the Race Marshal. The Chief Veterinarian(s) will be included in all decisions involving dog treatment and welfare.

Warnings may be issued for first time minor infractions.

Monetary penalties may be imposed up to \$500.00 for each violation. Such penalties may be deducted from prize money. A musher with unpaid fines may not enter future CD 150 races until such fines are paid.

Censure

The CD150 Board of Directors, following completion of the race and upon recommendation of the Race Marshal and/or Chief Veterinarian may censure a musher. A censure may include a warning, either in public or private, and may eliminate the musher from future races.

Disqualifications

Mushers may be disqualified for any infractions, including but not limited to physical abuse of a dog, cheating, or deliberate rule infractions which give a musher an unfair advantage over another musher.

A musher will be allowed to continue racing while a decision is being made, except in cases involving cruel or inhumane treatment of dogs.

Any musher who violates any local, state or federal law while competing in this race may be disqualified from future races if convicted.

Disqualification will result in the forfeiture of all race placements and monetary awards.

Each musher shall provide and sign any and all documents requested by the CD150 Board of Directors prior to entering the race. Failure to do so may result in disqualification.

Protests

Any musher wishing to lodge a protest must do so verbally at the first checkpoint following the occurrence of the act or situation to be considered.

All protests shall be lodged with the Race Marshal or a Race Judge only and shall not be discussed with any other persons, including spectators or media.

Protests will be decided by the Race Marshal and Race Judges no later than 1 (one) hour before the Awards banquet.

CopperDog 150 Protests

Following the verbal notification, a written protest must be submitted immediately following the race stage where the action occurred in Eagle Harbor, Copper Harbor, or the race Finish in Eagle Harbor. Protests must be submitted within 1 hour of musher's entering a checkpoint of finishing the race.

CopperDog 80 Protests

Following the verbal notification, a written protest must be submitted within 1 (one) hour of the musher's finish of the current stage - in Copper Harbor, or at the finish in Eagle Harbor.

CopperDog 25 Protests

Following the verbal notification, a written protest must be submitted within 1 (one) hour of the musher's finish of the race stage.

Appeals

A musher may appeal any decision made by the Race Officials (Race Marshal, Race Judge(s), and Race Veterinarians) by submitting a written request to the Race Marshal for a hearing and resolution prior to the Awards Banquet.

If the appeal pertains to a Judging decision, then the Race Marshal will present information as to the reason for the decision and the Musher will present information in his/her defense. Both sides may bring a witness or witnesses that can corroborate their story. Witnesses are limited to Race Judge, Race Veterinarians, Race Officials, race volunteers, or race mushers that have firsthand information concerning the situation being considered. A jury consisted of the Chief Veterinarian(s), Race Director (or Asst. Race Director or CD150 board member), and the Musher Representative (selected by the mushers at the musher meeting) will render a majority decision. Note: if the musher representative is unable to serve, the alternate will be called upon to serve.

If the appeal pertains to a Veterinary decision, then the Chief Veterinarian(s) will present information as to the reason for the decision and the Musher will present information in his/her defense. Both sides may bring a witness or witnesses that can corroborate their story. Witnesses are limited to Race Judge, Race Veterinarians, Race Officials, race volunteers, or race mushers that have firsthand information concerning the situation being considered. A jury comprised of the Race Marshall, Race Director (or Asst. Race Director or CD150 board member), and the Musher Representative (selected by the mushers at the musher meeting) will render a majority decision. Note: if the musher representative is unable to serve, the alternate will be called upon to serve.

17) The Race

Start/Finish

At the race start, all mushers, handlers, and team trucks must be in the official mushers' parking area at a specific time and location to be announced at the Friday mushers' meeting.

All **CD150, CD80 & CD25** teams will do a "Snub Line" start at Checkpoints where available. Not all checkpoints have the ability to set up snub lines. (See **Attachment 1**).

All **CD150** teams will have their bags checked before the Friday Calumet Start, at the Saturday Copper Harbor finish, and at the Eagle Harbor Finish.

All **CD80** teams will have their bags checked before the Eagle Harbor Start and at the Eagle Harbor Finish.

All **CD25** teams will have their bags checked before the Copper Harbor Start and at the Copper Harbor finish.

Start Timing

Mushers are assigned pickup times in advance by race officials. A race volunteer will remind each team of their pickup time at 15 minutes prior to that pickup time. Mushers must have their teams hooked up and ready to go at their pickup time. Volunteer handlers are available to help move dog teams to the starting gate.

If a musher has missed their pick up time and is not ready to go by 2 minutes before their starting time, the musher will be assessed a penalty decided by the Race Marshal. The team in question may be moved to start the race after the last team has left the chute in their class. If this happens with two or more teams, they will leave at two-minute intervals in the order that they were originally scheduled to leave.

If a musher has missed their pick up time, but is able to make it to the starting chute within 1 minute past their scheduled departure time, they will be started at the race's first available convenience. Each situation will be reviewed by the Race Marshall and a penalty may be assessed.

If a musher happens to leave early from the starting gate their start time will be the time they were scheduled to depart.

If the **race is at fault** for not delivering a musher to the starting chute on time, or the musher is brought up out of order **by the race**, the musher will depart the starting chute at the first opportunity while ensuring the least amount of interference of other starting teams. The recorded time will be the actual time the musher left the chute. A team arriving late to the starting gate will not be allowed to interfere with the start of teams who arrive on time.

Subject to compliance with all race rules, regulations and determinations of the Race Marshal, a team finish time, as well as the time into each checkpoint, is measured when the nose of the lead dog crosses the finish line.

Should any of the mandatory gear be missing a penalty may be assessed for each item missing. Expendable or consumable gear (e.g. booties, food) need not be present on arrival at a checkpoint or at the finish.

Checkpoints

Each musher must sign in and out personally from each checkpoint.

All **CD150 & CD80** teams must submit to a mandatory Vet Check at the Copper Harbor checkpoint upon finishing **Saturday March 5th, 2022**. It is the musher's responsibility to locate a veterinarian or race official to schedule the vet check. The musher must have the dogs checked 45 mins after arrival at the checkpoint. The musher must not box dogs until vet checks on their team have been completed. The vet checks will be assigned as teams arrive at the finish line, with the exception of a team needing immediate veterinarian attention. Having a dog pass the vet check in the checkpoint does not automatically guarantee that the dog will not be removed from the team before departure should the dog's physical condition deteriorate or a previously undiagnosed injury be diagnosed before the team has left the checkpoint.

All **CD25** teams must submit to a mandatory Vet Check at the Copper Harbor Checkpoint prior to the start on **Saturday March 5th, 2022**

Dogs may be dropped from a team only at official checkpoints.

Any musher leaving his/her team at an assisted checkpoint must do so only if a handler is available to supervise the team.

Accommodations (space for bedding down dogs, restrooms, parking space, etc.) will be assigned on a first come, first served basis.

Efforts will be made to give mushers every advantage in this regard, but no guarantees are tendered.

Most checkpoints will have running water available; the CD150 Race Organization will try to make arrangements in this regard. Each musher and his/her handler(s) are responsible for having the necessary food and water buckets at the checkpoints.

No **CD150** handlers or trucks should be along the trail at any point. Handlers proceed directly to the next checkpoint.

A fine of up to \$100.00 may be assessed against any team not cleaning up their site before leaving each checkpoint.

Outside Assistance

No outside assistance other than that planned by the race giving organization is permitted between checkpoints. Exceptions may be made under emergency conditions as determined by the Race Marshal or a Race Judge.

Mushers may aid each other in appropriate ways under emergency conditions.

Outside assistance with repairs to broken or destroyed equipment may be allowed under the supervision of the Race Marshal or a Race Judge.

Mushers may receive assistance in cases of uncontrolled or lost dog teams. Outside assistance must be accepted if a musher has lost complete control of a team; this includes motorized assistance. The Race Marshal or a Race Judge must be notified of such a circumstance and will rule on its validity.

A musher may not receive assistance from any motorized vehicle between checkpoints except in the case of a medical emergency or a lost team. Pacing with a vehicle is prohibited. Dog trucks and/or handlers are allowed only at official assisted checkpoint drops unless helping a team that has officially scratched from the race.

Handling and treatment of Dogs

The cruel and/or inhumane treatment of dogs by any musher or handler as determined by the Race Officials is strictly prohibited.

In the event a team gets away from the musher, it will not be disqualified if the musher regains control provided they have not left the racecourse. If the team and the musher have left the racecourse, they must re-enter the course at the point they left it.

All dogs on a team must be in harness and attached to the sled. No loose leaders will be permitted. A musher must make every effort to secure a dog which becomes loose accidentally. Dogs not in the team gangline must be restrained in the sled basket at all times during the course of the race.

It is the musher's responsibility to check for traffic at road crossings on the racecourse. CD150 Board of Directors will attempt to secure road crossings, but final safety is the musher's responsibility.

Two or more teams may not be tied together except to assist a musher at some single location along the race route. Mushers involved in such a situation must notify a race judge at the next checkpoint along the trail. No penalty will be assessed if a musher is aiding another race participant in danger for his/her life.

A musher may have another team haul his/her dogs only if they agree and if the musher is hauling two or more dogs already.

Any dog expired on the trail must be covered and transported in the sled to a checkpoint. The musher may transport the dog either to the checkpoint just passed or the upcoming one. Once at the checkpoint the musher must notify a race official with the protocol discussed at Friday's mushers' meeting. The musher must then complete a report and present it to the Chief Veterinarian(s). All expired dogs will be necropsied by the Chief Veterinarian(s) per ISDVMA guidelines. Tissue samples will be submitted for veterinary pathologist examination as deemed necessary.

Forced rehydration of a dog is the responsibility of Race Veterinarians only. Any dog entering a checkpoint requiring emergency or forced rehydration must be dropped from the team and placed under medical supervision.

The Race Course

Teams must stay on the race course. If the team and the musher have left the race course, they must re-enter the course at the point they left it.

When overtaking another team, the musher must call "TRAIL" if/when he or she wants the overtaken musher to relinquish the trail. The slower team must relinquish the trail immediately when "TRAIL" is called and assist the passing team if necessary. Sticks and other poling aids cannot be used within 100 feet (either behind or in front) of another team and must be stowed when a musher calls for trail. When neither team is able to pull away from the other, the mushers shall agree mutually on the appropriate team to lead out. Penalties will be assessed if this procedure is not followed.

No Man's Land starts one (1) mile from the finish line and will be well marked. Mushers will no longer have the option to call "TRAIL" nor will mushers be required to relinquish the trail. Sticks and other poling aids must be stowed in No Man's Land.

All race participants must abide by state and federal laws governing the transportation and use of firearms and the killing of game and nongame wildlife. In the event a musher kills a game animal protecting his life or that of his dogs, the musher must field dress the animal and then report the incident to a race judge at the next checkpoint. The CD150 Race Organization will take responsibility for recovering the animal.

Mushers breaking along the trail are required to ensure that the racecourse is clear of all dogs and gear.

The race will continue under all but the most severe of weather conditions. Mushers must come prepared to contend with cold, wind, storm conditions, and bare sections of trail. In the event of questionable trail

conditions, the BOD will make the decision to postpone or cancel the race no later than the Wednesday of race week. After the start of the mushers' meeting, the Race Marshal will assume all responsibility for any further postponement or alteration of start/finish locations.

The primary consideration will be the safety and well-being of the dogs and mushers, not the comfort of the musher.

Mushers observing littering on the trail are encouraged to report it. A musher may be fined up to \$100 for intentional littering. A time penalty may also be imposed at the discretion of the Race Marshall.

Any team that does not demonstrate satisfactory forward progress (is "late" into a crossing) may be disqualified by the Race Marshall or a Race Judge. As the first team reaches each crossing a "best time" is recorded for that crossing. All subsequent teams must have a time that is at least 65% of the fastest time (specific to each race, there is a fastest time for the 150 and one for the 80). A team's progress is evaluated by considering their departure time and the best team time at any crossing. Each team will therefore have a "deadline" for reaching each crossing. Any teams arriving after their "deadline" may be disqualified by the Race Marshall or a Race Judge.

Unsafe Conditions

Should the Race Marshall determines that an emergency event, an unsafe situation, or unsafe conditions, including weather or trail conditions, may affect the race, the Race Marshall may 1) reroute, shorten, or cancel any stage of the race; 2) stop a team or teams from competing 3) cancel the event and not restart the race and/or 4) stop the race until an emergency situation is resolved (**See Attachment 2**). Should a situation occur where the Race Marshall makes such a change, each team's overall finishing position will be determined by each team's overall accumulated trail time.

18) Claims

Each musher agrees to hold the CD150 Board of Directors, the race sponsors and other contributors (as distinguished from individual sponsors of mushers and teams) harmless from any claim or demand based upon any alleged action or inaction by the musher, his/her dogs or others acting on his/her behalf.

The CD150 Board of Directors claims unconditional authority to allow race sponsors to film, photograph or otherwise collect and document information about the race and race participants for use in advertising, public relations or other publicity purposes.

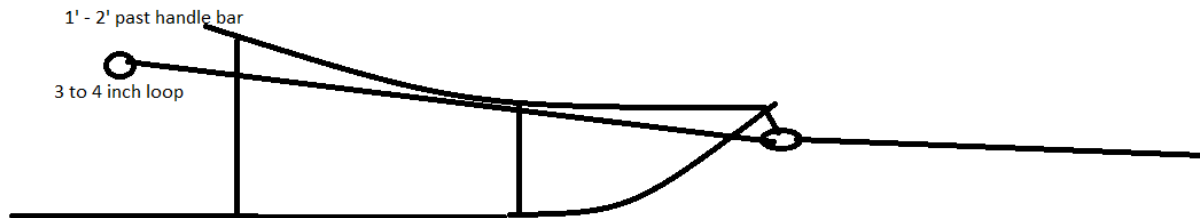
Each musher shall sign any and all documents as may be requested by the CopperDog race to accept the foregoing statements and conditions. Failure to do so will result in disqualification. All documents will be presented to the musher at Registration or will be included in the musher entry packet.

Attachment 1

Snubline Start

For safety of the dogs, musher, and volunteers at the start line, a snubline will be used for all the checkpoint starts. There will be no chain for snow hooks.

Snub lines shall extend at least 1 foot but no longer than 2 feet beyond the handle bar. Loop should be approximately 3-4" in diameter. No metal rings. Snub line can be adjustable to run off either the right or left side of the sled, but there will be a line on the right and left of the start line to connect to the snubline from the sled.



Attachment 2

Race stop for violence/Trail emergency policy

The Copperdog race organization strives to have a safe race for all participants, volunteers, and officials. A non-race related trail emergency, or a race related violent incident must be considered. To that end, the following will be the procedure if an emergency situation creates an unsafe situation for mushers to continue forward on the trail.

If a trail emergency is reported, the Race Marshall will determine whether the emergency warrants mushers behind the emergency to be stopped in place. If that decision is made, mushers will be stopped at the crossing prior to the trail emergency and held there. All mushers ahead of the trail emergency will continue normally to the next checkpoint. The following steps will happen next:

- The appropriate emergency agency will be immediately notified of the location of the emergency and the best location information available.
- The Race Marshall and/or a Race Judge will proceed immediately to that crossing.
- The timer at that crossing will note the time and bib number at which a musher is stopped
- Mushers may receive assistance if requested while their team stopped
- The Race Marshall and Race Director with assistance from the Chair of the Board, will determine when the trail is safe for the mushers to continue
- The timer at that crossing will note the time and bib number at which a musher is started again
- Mushers will restart from the crossing in 2 minute intervals in the order in which they arrived at the crossing
- The Race Marshall will compile the stop times and convey them to the Chief Timer in person or via radio
- The amount of time stopped for each musher will be deducted from the total time for that race segment

Attachment 3

COVID-19 Preparedness Plan -2022

The 2022 CopperDog may be subject to restrictions based on COVID-19 guidelines issued by the State of Michigan. Updates to the CopperDog Covid plan will be given as the race approaches and will be based on current CDC, State, local and Health Officials guidelines. Mushers, teams, race officials, volunteers and spectators should be aware that CopperDog will comply with recommendations from all of the above named organizations/people, and will enforce COVID-19 safety measures as appropriate. These measures may change up to and after the start of our race. It is requested that all participants, officials, volunteers and spectators at a minimum have a mask available should guidelines call for wearing them. If masks are required, it will be enforced throughout the race weekend, and non-compliance will result in disqualification from the race. CopperDog is committed to providing a safe and healthy workplace for all our race officials, contractors, volunteers, and mushers.

Below is a copy of the COVID-19 plan from 2021 for review and possible implementation should it be required.

CopperDog officials, contractors, volunteers, and mushers are all responsible for implementing this plan. Our goal is to mitigate the potential for transmission of COVID-19 in our race, race planning workplace, and our race communities. ***That requires full cooperation among all race officials, contractors, volunteer workers and participating mushers.*** Only through this cooperative effort, can we establish and maintain the safety and health of all persons and dogs in our race.

Due to the rapidly changing situation with the COVID-19 pandemic, this plan will be reviewed on a regular basis leading up to the race and any changes will be made, as necessary, to address the current conditions in Upper Michigan and our local communities. Both the CDC and the Michigan Department of Health policies and procedures will be reviewed on a consistent basis leading up to the race event.

The COVID-19 plan is administered by Doug Harrer, CopperDog Board Chair, who maintains the overall authority and responsibility for the plan. However, race officials, contractors, volunteers, and mushers are equally responsible for supporting, implementing, complying with, and providing recommendations to further improve all aspects of this COVID-19 plan. CopperDog race officials and volunteers have the CopperDog Board's full support in enforcing the provisions of this plan. Clear communication of the plan will be made available on the CopperDog website, and any questions regarding the plan can be directed to Doug Harrer via email (dougharrer@copperdog150.com) and any concerns or questions will be addressed.

Stakeholder Involvement in Creating the Plan

Our race officials, contractors, volunteers, and mushers are our most important assets. The CopperDog organization is serious about safety and health and protecting everyone involved in the race. Race officials, contractors, volunteers and mushers involvement are essential in developing and implementing our successful COVID-19 Preparedness Plan. We have involved other races in the Midwest, namely the John Beargrease Sled Dog Marathon, along with race officials, volunteers, and CopperDog Board members, in order to create a comprehensive plan to keep our participants, volunteers and our communities safe.

Topics Addressed in the Plan

CopperDog is a volunteer-based and volunteer-run organization. All volunteers will know of the COVID-19 plan and sign off on it before participating in race weekend and performing any duties associated with the race.

We will involve our race officials, contractors, volunteers, and past mushers in this process in the following ways:

- ensuring sick workers, volunteers, race participants and race officials stay home
- prompt identification and isolation of sick persons
- physical distancing – workers, participants, and volunteers must be at least six feet apart
- worker hygiene and source controls, including face coverings
- communications and training practices and protocol.

Other conditions and circumstances included in the industry guidance and addressed in the plan that are specific to our race include:

1. Traditionally, CopperDog is a spectator friendly event where thousands attend the start of the race in Calumet, MI. This year CopperDog will encourage spectators to watch the race virtually and stay home.
2. **CopperDog will enlist the assistance of local law enforcement should the need for crowd control arise or presence of non-compliant spectators become an issue.**
3. During the event, everyone in attendance will be required to wear face coverings AT ALL TIMES. This will be communicated in all pre-race communications to all mushers, handlers, volunteers, veterinarians, media, and race officials. Signs will be posted at all entrance locations and throughout the event locations.
4. Extra masks will be available at sign locations. All race officials will also be carrying extra masks to distribute as they circulate around the race location. Anyone claiming a mask exemption will be expected to limit their physical interactions with others and must wear a face shield in place of a mask.
5. All CopperDog event locations will be roped or fenced off with monitored gates to ensure that only allowed race participants enter. Access will be monitored by race officials and all permitted persons will have a pass on a lanyard arm band to signify that they can access the event.
6. Access to any indoor facilities will be strictly limited to a few race officials and veterinarians.
7. All mushers, handlers and volunteers will be required to use outdoor portable bathroom facilities which will be available at all race locations. Hand sanitizer will be provided in all portable bathroom facilities with signs reminding everyone to use it. Refill hand sanitizer will be present at all race locations and one race official will be tasked with ensuring that it is refilled before it runs out.
8. Every musher will receive a 2-ounce bottle of 60% alcohol-based hand sanitizer solution.
9. The nature of a sled dog race is that the event is almost completely outdoors. Having all but a very few essential personnel outdoors, will limit the possibility of the transmission of COVID-19 or any other pathogen.
10. All persons at CopperDog will work in small teams to limit group interaction. Race veterinarians, officials, volunteers, and media will function in groups of **5 or less**, maintaining physical distance from other work groups and, as much as possible, from each other.
11. **When individuals are unable to maintain an adequate 6 feet distance, a face shield is also recommended in addition to a face mask.**
12. All sled dog teams will be parked at least 10 feet from the nearest sled dog team. Once a team has parked in a specific location, *no other team will be allowed to park in that location for the duration of the event*. The only persons that will be allowed to closely interact with each team at its parking location will be race veterinarians. When race veterinarians are present with the sled dog teams mushers and their handlers will keep at least 6 feet distance from them.

13. To help ensure that the total persons in attendance remains low in numbers, CopperDog will implement a new race schedule, separating the two race events.
14. Once all mushers from one event leave the race starting chute, their trucks and support teams should also leave the race starting area, if possible. Teams for the next event will then be allowed to enter. All teams will be parked in fresh parking locations, where no team has previously been parked.
15. For each race, the follow will be implemented:
 - a. A maximum of 25 will be allowed to participate in the CopperDog 150 race.
 - b. A maximum of 20 teams will be allowed to participate in the CopperDog 25 race.

The total attendance of mushing teams at CopperDog this year will be only 45 this year.

Ensure sick race officials, contractors, volunteers and mushers stay home and prompt identification and isolation of sick persons

All CopperDog race officials, contractors, volunteers and mushers will be encouraged to self-monitor for signs and symptoms of COVID-19. The following policies and procedures are being implemented to assess health status prior to entering the workplace and for workers to report when they are sick or experiencing symptoms.

Screening and Assessment

- All participants will receive a self-assessment checklist to assess their health upon entering the premises.
- All race participants and personnel will be screened for temperature.
- Individuals or anyone in their immediate family (living in the same home) reporting any of the following symptom(s) will not be permitted into the race grounds or associated checkpoints and will be asked to return home:
 - **Direct contact with a known COVID-19 positive individual, including contact with a member of the same household**
 - **Close contact (within 6 feet) with a COVID-19 positive individual regardless of whether the individual was masked**
 - A fever (100.0 or higher) within the last 72 hours
 - New loss of taste or smell
 - Shortness of breath
 - Chills; repeated shaking with chills
 - Muscle pain, not related to a prior condition
 - Direct household contact with a person experiencing an undiagnosed cough and fever
 - Diarrhea and/or vomiting within the last 24 hours

Contact Tracing

Attendance of all race participants, race officials, volunteers and CopperDog personnel will be taken to ensure contact tracing can occur accurately as possible, should anyone attending the event later report COVID-19 symptoms and/or a COVID-19 positive test result. Any information gathered for contact tracing will be retained

by CopperDog for a minimum of 14 days following the event. All information obtained will be maintained by CopperDog and will be kept confidential.

Illness Assessment

Any individual showing any signs or symptoms of illness while on site will be asked to go home immediately and contact their healthcare professional as soon as they are able. Attendance and contact information of CopperDog participants will be taken should the information be needed by healthcare professionals for tracking purposes. Again, this information will be kept confidential by the CopperDog organization. Back up race officials, contractors, and volunteers will be available for all race functions for CopperDog.

All mushers will be informed, with their race registration materials, that a full refund will be granted to anyone who must withdraw from the CopperDog race for COVID-19 related issues.

CopperDog will also implement a policy for informing race officials, contractors, volunteers, and mushers, should they be exposed to a person with COVID-19 during any and all CopperDog-related activities, along with guidelines for the appropriate required amount of time for quarantine. CopperDog will include language describing our policy in all race registration materials for race officials, volunteers, and mushers. All persons mentioned will be required to sign a COVID-19 Attestation Form confirming they have read and that they understand our policy.

In addition, a policy will be implemented to protect the privacy of race officials', contractors', volunteers', and mushers' health status and health information. Race Officials will all be trained on how to respond to all COVID-19 related reporting from others who are involved in the race. They are to receive that information privately and then inform the CopperDog Board Chair. Information will be given to the Michigan Department of Health, as needed.

Face Coverings

Face coverings are required by everyone in attendance and compliance is mandatory. This will be communicated in a pre-race communication to all mushers, handlers, race officials, veterinarians, and race volunteers.

Extra masks will be available at signed locations. All race officials will also carry extra masks to distribute as they circulate around race locations. Race officials, contractors, volunteers and mushers are being instructed to cover their mouth and nose with their sleeve or a tissue when coughing or sneezing, and to avoid touching their face, particularly their mouth, nose and eyes, with their hands.

Race officials, contractors, volunteers and mushers are expected to dispose of tissues in provided trash receptacles and wash or sanitize their hands immediately afterward.

Musher Hygiene and Source Controls

Basic infection prevention measures are always encouraged at all CopperDog activities. All race officials, contractors, volunteers and mushers are instructed to wash their hands for at least 20 seconds with soap and water frequently throughout the day, but especially at the beginning and end of their race involvement, prior to any mealtimes and after using the restroom. All race officials, contractors, volunteers and mushers are required to wash or sanitize their hands prior to or immediately upon arriving at all CopperDog-related activities. Hand-sanitizer dispensers (that use sanitizers of greater than 60% alcohol) will be at entrances to all CopperDog event locations so they can be used for hand hygiene in place of soap and water, as long as hands are not visibly soiled.

Access to any indoor facilities will be strictly limited to a few race officials and veterinarians. All mushers, handlers and volunteers will be required to use outdoor portable bathroom facilities which will be available at all race locations. Hand sanitizer will be provided in all portable bathroom facilities with signs reminding everyone to use it. Refill hand sanitizer will be present at all race locations and one race official will be tasked with ensuring that it is refilled before it runs out.

Portable bathroom facilities will have cleaning and disinfectant available with signage asking users to disinfect after each use.

Physical Distancing

All CopperDog race officials, contractors, volunteers, and mushers must be at least six feet apart.

Physical distancing of at least six feet will be implemented and maintained between race officials, contractors, volunteers, mushers, and handlers during all CopperDog-related activities through the following protocols:

1. Signage will remind people to respect 6-foot distancing expectations at all pre-race events.
2. Volunteers will provide verbal admonitions to those not following appropriate 6-foot distancing.
3. Participation will be limited in the 2021 race to allow for physical distancing.
4. Any common surfaces (a pen and clipboard for signatures, for instance) will be cleaned with alcohol wipes in between uses where possible. Sharing supplies should be avoided.
5. Prior to the start of the race, participants will be expected to sign off digitally regarding their awareness of the physical distancing expectations.
6. Prior to the start of the race, participants will be asked to stay home if they are sick. To reinforce this, CopperDog will offer a liberal refund policy for the 2021 race. This will include any musher who becomes ill with COVID-19 before the start of the race.
7. Musher vehicles will be parked at least 10 feet from one another to allow for dog movement and keep a good personal distance.
8. All mushers must have their own equipment to minimize any sharing of equipment or gear.
9. There will be an adequate supply of hand sanitizer (with at least 60% alcohol) for all participants.
10. Public garbage cans will be placed in such a manner as to allow people access from all sides.

11. During the musher meetings and bib draw, which will be held outdoors, people must maintain physical distancing expectations. Signage will be used every 10 feet to remind participants.
12. No tables or chairs will be set out for participants. They may bring their own chairs.
13. Portable toilets will be placed at least 6-feet apart.
14. **Face masks will always be required at all race locations.**

All pre-race communications will also include these requirements. Musher and volunteer registration will include a check off to signify that the person has read and acknowledges these requirements.

Workplace building and ventilation protocol.

Operation of all facilities, which CopperDog uses during race activities, will meet Michigan Stay Safe workplace standards for necessary sanitation, assessment, and maintenance of building systems, including water, plumbing, electrical, and heating, ventilation and air conditioning (HVAC) systems. All indoor facilities used during CopperDog will have their own approved Michigan COVID-19 Plan which meets all necessary workplace standards. For the 2021 CopperDog will make minimal use of all indoor facilities and instead hold all major activities outside to minimize COVID-19 exposure. CopperDog will also request copies of all partner facilities' COVID-19 plans and will have those available for inspection. **Buildings included in this protocol will be:**

- **Calumet**
 - **Incredible Bank- Business will follow their COVID-19 Policy.**
- **Eagle Harbor**
 - **Eagle Harbor township building will have limited access with CopperDog Race personnel/staff.**
- **Copper Harbor**
 - **Copper Harbor Community Center will again have limited use by CopperDog Race personnel/staff.**

Workplace cleaning and disinfection protocol for all partnering facilities

All public and private facilities which CopperDog partners with for the 2021 race will have an approved Michigan COVID-19 Plan. These plans will ensure that regular practices of cleaning and disinfecting have been implemented, including a schedule for routine cleaning and disinfecting of work surfaces, equipment, tools and machinery, vehicles and areas in the work environment, including restrooms, break rooms, lunchrooms, meeting rooms, checkout stations and drop-off and pick-up locations. For all CopperDog partnering facilities, COVID-19 plans will demonstrate frequent cleaning and disinfecting is being conducted of high-touch areas, including phones, keyboards, touch screens, controls, door handles, elevator panels, railings, copy machines, credit card readers, delivery equipment, etc. For all CopperDog partner facilities, COVID-19 plans will demonstrate appropriate and effective cleaning and disinfecting supplies have been purchased and are available for use.

Communications and training practices and protocol

This COVID-19 Preparedness Plan will be communicated to all race officials, contractors, volunteers and mushers *prior to their arrival at any CopperDog Race location* and necessary training will be provided as needed. A pre-race training meeting will be scheduled at least two weeks prior to the start of the race.

Historically, all CopperDog race volunteers receive volunteer training prior to the race. The location and time depend upon the type of position they are being trained for. Most volunteers receive training several days prior to the race because of the specific type of work they will be volunteering to do. Some volunteers will receive their training the morning of the race because of the simpler nature of their task.

ALL volunteers will have the CopperDog COVID-19 protocols as part of their training. Instructions will be communicated to all CopperDog race officials, contractors, volunteers and mushers about protections and protocols, including:

- physical distancing protocols and practices.
- drop-off, pick-up, delivery, and general instore shopping.
- practices for hygiene and respiratory etiquette
- requirements regarding the use of face coverings and/or face-shields.
- All race officials, contractors, volunteers, and mushers will also be advised not to enter the workplace if they are experiencing symptoms or have contracted COVID-19.

Implementation of the Plan

CopperDog Race Officials are expected to monitor how effective the preparedness plan has been implemented. All CopperDog race officials, contractors, volunteers and mushers are to take an active role and collaborate in carrying out the various aspects of this plan, and update the protections, protocols, work-practices and training, as necessary.

This COVID-19 Plan will be presented to all required permitting entities with whom the race works with. It will be updated as necessary by Doug Harrer, CopperDog Board Chair, and the CopperDog Board of Directors.

The CopperDog organization realizes that circumstances are likely to change in some way. The CopperDog organization remains committed to adjusting the plan and its implementation, as needed, to provide a safe event possible, for all those who participate.
